CIRCULAR

Dear Parents/SJBITians,

The COVID-19 pandemic has affected all the sectors including educational systems worldwide. Govt. of India / Govt. of Karnataka has allowed the opening of Professional Colleges (Engineering) from **04**th **January' 2021, Monday** onwards and permitting the educational institutions to conduct off line classes to students strictly following the Standard Operation Procedure (SOP) and as per the Government and VTU University Directions. Students are allowed to attend the Campus classes from **04**th **January'2021**.

We, at SJBIT have made elaborate arrangements for conducting the offline classes from **04**th **January'2021**, **Monday** in the department with Standard Operating Procedures (SOP). The entire Campus is being sanitized periodically, including all labs, class rooms and study areas further hostels are ready for occupation as per Standard Operating Procedure (SOP) facilitating one occupancy per room. SJBIT Library and Information Centre has promulgated the rules and regulations for accessing library facilities. Department wise committees headed by respective HOD have been constituted to monitor the welfare and safety of your ward.

Therefore, we request the co-operation of all the parents in sending your wards to the College with your valuable advice to wear the mask and gloves, always maintain social distance & wash hands/sanitize as often as possible.

The following precautions are being taken to ensure safety of the hostel students.

- 1. Strict social distance (2.5 mtrs) is to be maintained among the students and staff of the hostels and all staff have been advised always be on masks and sanitizers are provided at multiple points.
- 2. The groceries procured for the Hostel are sanitized and properly stored in identified disinfected storage area.
- 3. Preventing students not to go out of the campus to ensure their safety.
- 4. Committee headed Chief Warden has been constituted to help students by monitoring the activities of students in hostel premises.
- 5. Isolation rooms are available in Hostels in case of any student is identified with the symptoms of COVID-19 and Campus doctor is available for consultation. (for more detail please refer SOP of SJBIT Hostel)
- 6. As per the instructions from the State Govt. students have to submit COVID-19 (RT-PCR) examine report (three days prior to the commencement date **04**th **January'2021**, **Monday**).
