
- 1) The registration of the students to the semester on the first day of the commencement of the semester is compulsory.

- 3) The detailed examination notification will be issued by Controller of Examination (COE) time to time.
- 4) Academic Calendar may be modified based on guidelines/directions issued in the future by VTU/UGC/AICTE/State Government.
- 5) **Vocational Training Program (VTP):**
 - i) Vocational Training Program shall be conducted as per the academic calendar & guidelines issued time to time.
 - ii) The attendance of the students for the Vocational Training Program is compulsory and shall determine the eligibility criteria for the SEE of the VI semester.
 - iii) The organizers to record and monitor the attendance of the students as per the Vocational Training Program schedule. The respective department HODs shall supervise their student's participation for the Vocational Training Program.

 - ii) The respective department HOD shall prepare the department level calendar of events incorporating the department level activities and publicize to all the stakeholders.
